BOARD HAPPENINGS

Your Board met on July 7th, 2018 at the community pool.

<u>Annual Dues Status:</u> 675 WL was sold on the Courthouse steps on May 3, 2018. The \$615 prorated dues for the remainder of 2018 was collected. The prior year \$400 special assessment, other portion of 2018 dues of \$315 and the lien cost of 92.50 was unable to be collected. The association lost \$807.50. The other homeowner that was delinquent for over two years owed \$1962. Multiple letters to owner went unanswered and even a payment option was offered to no avail. Unfortunately, the Board had no other option but to foreclose on the property. As a result, the total amount has been collected as well as all attorney and processing fees of an additional \$2550! Owner was able to obtain financing to avoid foreclosure.

Fees and Liens: The Board voted and approved in January, 2018 timelines for fees and liens regarding annual dues so the community is protected financially. A \$10 fee for each certified letter was also approved in January, 2018 and will be charged to owner. At the next meeting, the Board will address timeline and fines for Homeowners that have not completed painting as well as those not maintaining their property to include the yard.

<u>Status of Pool project:</u> Clarified with Health Inspector all items were completed and pool certificate issued.

Status of Painting on Pine Forest: Several homeowners have not painted or are only partially painted. Deadline was March, 2018. Guidelines presented earlier this year and posted on the website must be followed. Please advise a Board member the status of your unit being scheduled/completed. Many have not provided receipts for confirmation of painting.

Status of Unkempt Lawns/Properties: Some certified letters have been sent and some yards unresolved yet. More letters to be sent. Many still need to pressure wash driveways and walkways yet. We ALL have a responsibility to maintain our yards and each owner will be held accountable.

<u>Pool Reservations:</u> VP Johnson is back to coordinating all reservations. Please contact him for all pool reservations!

<u>Basketball Hoop on Willow Oak:</u> Haven't seen it up for quite some time. Hopefully resolved.

<u>Massey Termite Bond:</u> President Berk to follow up with Massey regarding service. We certainly don't want to lose our bond since there's been no increase in cost since the initial install.

<u>Annual HOA Planning</u>: - Details to be finalized at next meeting.

<u>Repairs/Landscaping</u>: Larger Menu Board - details to be finalized at next meeting.

Review of Contracts:

Higdon renews in August. Emails and texts sent to Higdon for renewal have gone with no response. At time of printing of newsletter, an agreement has been made.
